

AFFILIATE PROGRAM

Program participation terms:

- You must be a registered customer in the Inanomo services, you should read the current version of the Affiliate Program Rules and accept these conditions in the profile of your personal account on the page “Affiliate Program”, after then a special link with a unique partner id will be available on the page (hereinafter “Affiliate Link”).
- Users who have registered in the system through the affiliate link or indicated the partner’s id during registration are considered attracted to the Partner (hereinafter “Invited users”).
- Users attached to the Partner cannot be detached from this partner.
- Users previously registered in the Inanomo services without indicating the partner’s id or attached to another partner cannot be attached to the Partner.

Bonuses accrual:

- Bonus from trading operations:
 - The amounts of the received and calculated bonuses will be indicated in the personal account on the Affiliate Trading Statistics page.
 - Bonus amounts shall be calculated separately for each invited user and each trading operation performed by the user.
 - Bonus is calculated in the currency of the trading operation.
 - Bonus is accrued to the partner’s master account in Inanomo Wallet.
 - Bonus is accrued once a week.
 - Bonus amount is 50% of the fees from the trading operations of the invited user.

Bonus from trading operations

The bonus is calculated in the currency of the trading operation and it is credited weekly to the master account in Inanomo Wallet

- Bonuses from investment products:
 - The amounts of the received and calculated bonuses will be indicated in the personal account on the Affiliate Investment Statistics page.
 - When working with a managed account, replenishment bonuses and profit bonuses can be paid at the discretion of the manager. Availability and amount of bonuses will be indicated by the manager when registering a manager account.
 - Bonus amounts shall be calculated separately for each invited user and each account into which the user invested funds.
 - Bonuses are calculated in the currency of the managed account.
 - Bonuses are accrued to the partner's master account in Inanomo Investment.
 - If the bonus amount payable is less than 0.01 USD, this amount will not be credited to the partner's master account. The bonuses will be saved on the buffer account until they exceed 0.01 USD, and then will be credited to the partner's master account on the next day of the accrual of bonuses.
 - Replenishment bonus:
 - Bonus is accrued once a month on the last trading Friday of the month.
 - The amount of investment attracted by the Partner is calculated from the amount of all the invested funds of the invited user minus the withdrawn funds, taking into account the profit received.
 - Bonus amount is calculated basing on the difference between the current amount of investment attracted and the amount of investment attracted on which the bonuses have already been accrued.
 - Bonus from the invited customer's profit:
 - The bonus is accrued at the end of each trading period.
 - Bonus amount is calculated based on the total profit of the invited user on the investment account for the entire time of investment into the account.

Bonuses from investment products





- Individuals and legal entities engaged by the Partner, referred to as Customers, enter into contracts and sign/accept any required documents in accordance with the terms and conditions of the Company.
- The contracts, as well as all and any supplementary agreements to them, shall be entered into directly between the Company and the Customers.
- The partner has the right to carry out the following activities:
 - Carry out promotional activities in the interests of the Company;
 - Carry out activities aimed at finding new Customers for the Company;
 - Inform the would-be Customers about the scope of activities and services offered by the Company, the competitive advantages of the Company, etc.;
 - Provide the would-be Customers with all the necessary information about the Company, including addresses and contact details of the Company, general and special conditions for the provision of services;
 - Provide the would-be Customers with information about the Company's official website inanomo.com and its structure, refer to documents and information posted on this site, comment and explain it;
- Perform the necessary consulting of the would-be Customers along with other legal actions that further facilitate contracts between the Company and the Customers, as well as their effective mutual relations.
- In the event when a partner's actions contravene to the interests of the Company and might adversely affect the Company's business image and reputation, the Company, has the right to unilaterally disable the affiliate link, without any payments and compensation to the Partner.
- The partner shall not, under any circumstances:
 - Act on behalf of the Company (negotiate and sign any documents on behalf of the Company, be represented by the Representative Office or another division of the Company, as well as an employee of the Company, a trustee, etc.);
 - Agree on the terms of contracts and other legal relations concluded directly between the Company and the Customer;
 - Sign contracts and supplementary agreements to them on behalf of the Company;
 - Accept funds from Customers on behalf of the Company, including commissions, fees, fees and/or interest, on direct relations between the Company and the Customer. In exceptional cases, upon prior written approval from the Company, the Partner may render independent additional services to the Company's customers, organizing the transfer of funds to the balance sheet account of the Company. In such an event, the Partner is obliged to inform the person receiving this service that this service is carried out personally by the Partner and the Company has no relation to it, and also that the Partner assumes all responsibility before the Customer for such services, and that the Company does not charge any fees (commissions, etc.) for the provision of such a service;
 - Register and/or use domain names containing the abbreviation "inanomo", for example: inanomogroup, inanomoinvest, inanomo-forex, etc.;
 - Register an organization and/or use the name of the Company in the name of an already operating company, in any transliteration, either fully or partially;
 - Use any kinds of fraudulent advertising to promote their activities. In particular, it is prohibited to use:
 - Methods of promotion inconsistent with the regulations of Internet search systems, deliberate manipulation with the results of search queries and other promotion methods on the Internet, which mislead the search engine and search engine users.
 - Methods of misleading a website visitor by knowingly falsely redirecting such website visitor to another Internet resource or Internet page.
 - Advertising on unethical (not answering to the moral standards adopted in present-day society) sites;
 - Advertising on sites offending laws of the country of location of the Company and the Partner, including the Russian Federation;



- Spam (mass mailing of advertising and any other messages to persons who did not express the desire to receive them);
- Advertisements giving a deliberately misleading picture of the services offered, or deliberately concealing the risks and information about the services offered from the would-be Customers;
- Advertisements containing inaccurate information or violating the laws of the country where the Partner is located;
- Any other things that could harm the image of the Company.
- Register with contextual advertising systems such as Yandex.Direct, Begun.ru, Google Adwords etc., using the direct URL of the company's websites (inanomo.com, inanomo.ru, my.inanomo.com, my.inanomo.ru, etc.) with an affiliate link. It is also strictly prohibited to use redirects and other forms of forced redirecting users to the official websites of the Company.
